During the year 2022-23, the Indore Branch of CIRC of ICAI took various steps in building and enhancing the brand image of ICAI, some of them are as below:

## **CA Gate**

A Dedicated Gate by the Indore Municipal Corporation to be constructed at CA Street by their own funds (30 Lakhs Approx.) of which stone laying ceremony was held on 28<sup>th</sup> December 2022 in the auspicious presence of CA. (Dr) Debashish Mitra, Hon'ble President, ICAI along with CCMs and Past Presidents. This step by the Indore Branch is a phenomenal one in building the image of ICAI through Government funds.

## ICAI Participation in Pravasiya Bhratiya Sammelan (PBD) and Global Investor Summit (GIS) 8-12<sup>th</sup> January, 2023

#### 1. Pavilion in PBD & GIS

This pavilion occupied the most prominent location with a humongous size of 540 Sq ft. (Second Largest Size). It was given to us without any cost for the space. The Indore Branch played an instrumental role in getting it materialized. The pavilion was visited by more than 3000+ Participants. It is a matter of great honour to the entire fraternity through this endeavour.

## 2. Session during GIS

With the efforts of the Indore Branch, the government of Madhya Pradesh gave a dedicated session named "Access Madhya Pradesh, A complete Business Solution, curated by ICAI" in the summit. The session was addressed by Hon'ble President CA. (Dr) Debashish Mitra, Vice President CA. Aniket Talati along-with the Finance Minister of Madhya Pradesh Shri Jagdish Devda, ACS Shri Ajit Kesri and CEO of Mauritius Shri Ken Poonoosamy.

## 3. Compilation Booklet – Access MP at Indore

The Indore branch under the guidance of the PDC Committee constituted a group of members who have compiled all the legal and tax compliances required to be made for setting up any industry / unit at MP. This compilation includes compliances with respect to Taxes, Central & State Laws, Subsidies, Finance, Legal & Law Requirements, Land allotment Process etc. This effort will go a long way in creating the ease of setting up industries in the state.

## 4. Presentation of ICAI Booklet – Access MP to Various Dignitaries

To showcase the brand image of ICAI amongst the dignitaries of PBD and GIS the Indore Branch Managing Committee presented the ICAI Booklet to various dignitaries including Mohamed Irfaan Ali, Hon'ble President Guyana, Ms. Nirmala Sitaraman, Hon'ble FM, GoI, Shri Shivraj Singh Chouhan, Chief Minister MP, Shri CA. ## 5. Helpdesk at Pavilion

This spirit of coming together and making the event a huge success is very promising.

## **Tax & Finance Literacy Drive**
