In-Person verification must for GST Registration, new norms notified

Now, it would take 7 days for registration of Aadhaar authenticated applicant with proper scrutiny

Finance Ministry has notified new norms for GST registration. It expects this would help in checking the menace of fake invoices.

According to new norm, if the applicant has opted for Aadhaar based authentication, then every application will be followed by biometric-based Aadhaar authentication and taking photograph. In case the applicant does not go for first option, then the process involves taking biometric information, photograph and verification of various KYC (Know Your Customer) documents.

Authentication will be done at one of the Facilitation Centres notified by the Commissioner. This amendment will come into effect from a date to be notified in near future after setting up of facilitation centres on the lines of Passport Seva Kendras or Aadhaar Seva Kendras. New norms have been prepared on the basis of recommendations of Law Committee of GST Council.

Scrutiny

The new timeline for grant of registration for


Aadhaar authenticated applicant is now 7 days for proper scrutiny of application. To counter the cases of fake invoices, in a few risky cases where a person has successfully undergone Aadhaar authentication, some additional physical verification may be carried out with the approval of an officer, authorized by the Commissioner. The timeline for grant of registration in such cases would now be of 30 days.

Under the new arrangement, the suspension and cancellations would be based on data analytics and mismatches. A registration now is also liable for cancellation where the input tax credit is availed in violation of provisions of the CGST Act or the details of outward supplies in FORM GSTR-1 are in excess to the outward supplies declared in FORM GSTR-3B, for one or more tax periods. Such cases lead to ITC (Input Tax Credit) being passed or availed without payment of tax and would, therefore, be liable for cancellation of registration. During the proceedings of cancellation, these taxpayers would remain suspended.

# UNDERSTANDING AUTOMATION & RPA

The Biggest Game Changer in new decade

## INTRODUCTION

We heard about how automation will change the world and how it will satisfy the needs of manual workforces to build and deploy new processes on a day to day basis.


Whether it is a small or big organization all of them are aiming to automate its business processes in a way that it complements the manual strategizing and also the process remained uninterrupted

RPA is a new age technological marvel that utilized by enterprises to automate the day to day manual tasks include data extraction, invoices processing, processing portal queries and prices maintain, consumers data validation files and many more. Now performing this task without automation is quit tedious, the solution to this problem is Robotic Process Automation.

## WHAT IS ROBOTIC PROCESS AUTOMATION?

Robotic Process Automation is the technology that allows anyone today to configure computer software, or a “robot” to emulate and integrate the actions of a human interacting within digital systems to execute a business process. RPA robots utilize the user interface to capture data and manipulate applications just like humans do. They interpret, trigger responses and communicate with other systems in order to perform on a vast

variety of repetitive tasks. Only substantially better: an RPA software robot never sleeps and makes zero mistakes..



Let's take an example: Mr. Mittal is an accountant in multinational company, he handle several invoices for financial record like monetary transaction, liability, cheques, trade ledger on a daily basis one of his task to copy all the relevant information from this invoices such as “Name of the Company”, “Invoice ID” and Data processing into a spread sheet and mail a sheet along with all the relevant financial report to their superior by the end of the day as any prompt employee he transfer all the information to the spread sheet, attached a report and send to his boss by mail every day. But over a period finding this task is time

consuming and repetitive. Frustrated Mr. Mittal looks to reduce the time and efforts to complete the task.

So he came up with the Solution of RPA.

### HOW IS RPA DIFFERENT FROM OTHER ENTERPRISE AUTOMATION TOOLS?

In contrast to other, traditional IT solutions, RPA allows organizations to automate at a fraction of the cost and time previously encountered. RPA is also non-intrusive in nature and leverages the existing infrastructure without causing disruption to underlying systems, which would be difficult and costly to replace. With RPA, cost efficiency and compliance are no longer an operating cost but a by product of the automation.

### HOW DOES RPA WORK

As industrial robots transformed the factory floor, RPA bots can transform support functions and back offices. RPA Bots replicate employee actions like, opening files, inputting data, copy pasting fields in an automated way. To set up an RPA bot, it may not be necessary to know complex programming because solutions available in market are user friendly. RPA can be easily being managed from a central controller to enable interaction with variety of business applications. There are 4 ways to setup RPA bots.

### SETTING UP INSTRUCTIONS

The developer gives detailed instructions to robots to perform and interact with Robot Controller Library.

### ROBOT CONTROLLER

It is a core RPA Software which can be used to give jobs to the robots and monitor their activities with respect to performance of their jobs.

### ROBOTS


It can be machine or desktop or virtual system where it interacts directly with the Robot Controller and Business Applications.

### BUSINESS USERS

Business users of the organisation review the work of the robots and resolves any exception

and escalates, if required, to identify stakeholder for resolution.

In a long run, the bots can be self-learning to go the level of RPA for decision making. RPA is believed to revolutionize and redefine the way we will work and make us more smart and quick in processes, RPA as we see have commenced deployment in most large business and, will continue to grow and will adopt to be cognitive by next five years. Further, it is predicted by many that that is shall develop to machine learning platform probably by year 2025-2026.



### Robotics in Tax Function

All manual, repeatable, and time-consuming processes can be automated using RPA. In fact it is predicted that RPA will be the future of Tax Function. In cases where IT has already implemented Tax Function through technology solutions, then RPA can enhance its direct and indirect tax compliance and reporting.

RPA can execute activities related to the following direct or indirect tax function –

#### I. Examples of RPA corporate tax return-related tasks:

- ▶ Auto reconciliation of inter-company transactions
- ▶ Review accounts to ensure consistency with the prior year and note changes
- ▶ Analyse account changes and evaluate potential tax impact
- ▶ Populate tax returns with financial data

- ▶ Automated import of financial tax workbook into tax return forms (using tax return software)
- ▶ Complete non-financial tax return line items and information fields
- ▶ Execute work-flow processes for tax returns and initiate electronic estimated payments
- ▶ Gather and analyse high volumes of state apportionment data (from payroll, fixed assets, and financial systems)
- ▶ Auto-calculate and posting of current tax accounting
- ▶ Submit tax returns and related payments.

## ii. Examples of RPA indirect tax return-related tasks –

- ▶ Interact with bolt-on indirect tax solutions and financial systems to complete high volumes of tax returns
- ▶ Execute work-flow processes for tax returns and initiate electronic payments
- ▶ Gather transactional details and supporting invoices to analyse potential tax impact
- ▶ Export Industry-specific data for monitoring, evaluation and analysis
- ▶ Robotic Process enhancements can help the organisations to –
- ▶ Accelerate timing of the tax provision by reducing manual effort by up to 20%-35%
- ▶ Efficiently acquire and analyse financial data, creating legal entity accrual adjustments
- ▶ Significant impact on accuracy due to increased visibility into accounts
- ▶ Reduce the staff time operations used to perform low-value work (data extraction and manipulation).

### Myths about RPA

Like with any new system being brought into place, the maximum resistance is felt from those who do not understand its nature, tasks, and goals of its usage. Here are a few myths that need to be debunked, in order to comprehend the true potential of RPA.

### **RPA systems will replace humans completely**

This commonly held myth could not be further from the truth. RPA systems require human supervision for programming, information on daily tasks and maintenance.

Human intelligence includes creativity, emotion, reactions to adversity, ability to deal with change. All this intelligence that can remain unutilized due to mundane and repetitive work processes can be freed up – by implementing RPA tools and processes in organizations.

### **RPA is expensive**

RPA can offer a mix of tangible and intangible returns and benefits. Implementing an RPA process has performance benefits such as error-free processing, saving of time due to its usage, social benefits – such as the building the organization's reputation.

The administrative cost of the resource can also reduce a company's spends. After the initial investment, small to medium businesses can easily recover the cost of using RPA systems within 4-5 years.

### **RPA is only useful in software-related industries**

RPA can be used for small tasks that have nothing to do with heavy software. RPA bots can use operating system applications to launch and use various applications, integrating with enterprise tools, augmenting data and data processing.

### **RPA requires complicated coding**

Robotic Automation interacts with the existing IT architecture with no complex system integration required. The RPA is a software

program that is a sequence of commands executed by Bots under a defined set of business rules. It does not require the development of code, nor does it require direct access to the code or database of the applications.

### **ADVERSITIES TURNED INTO OPPORTUNITIES**

The era of early 90s was full of Unexplored adventures due to unawareness, degraded technology, poverty, illiteracy & the important one being, fear of risk taking abilities. So, he decided to enter into stock market by leaving the odd jobs & taking the heavy risks for higher returns.

Based on the book, The scam 1992 (Harshad Mehta story) Without questioning the legitimacy its a magical saga which took the hearts of the billion audiences. The central character being, Mr. Mehta remained in limelight, because he believed that "A large chair doesn't make a big king but a greater king surely makes his own big chair". Spectators should focus on the learnings and worthy extracts to trigger their thought processes.

### **THE TRIUMPH OF THE KING**

Harshad Mehta, worked hard & experienced the share markets to the fullest. As a result was crowned with the tittle of "Big Bull & was named as Amitabh Bacchan of the dalal street. His analytical skills & insider information (of the stocks) sat the bulls on run. At that time, a bank had to go through a broker to buy securities and forward bonds from other banks. Mr Mehta used this money temporarily in his account to buy shares, thus hiking up demand of certain shares (of good established companies like ACC, Sterlite Industries and Videocon) dramatically, selling them off, passing on a part of the proceeds to the bank and kept the rest for himself. This resulted in stocks like ACC (which was trading in 1991 for ₹200/share) to nearly ₹9,000 in just 3 months. Which was enough to convey his Midas touch, every stock he touched became gold. The dawn bought much glory to Me. Mehta's lifestyle, from the cramped chawls to some of the most plush apartments in Bombay consisting of the royal luxuries & The sleek Lexus. His beliefs hypnotised every stakeholder in the market, from the industrialists to the administrators.

## REIGN TO AN END

As the quote goes "Greed makes man blind & foolish, and makes him an easy prey of death" No doubt, Mr. Mehta was a man of integrity but his unending quest validated him to achieve more by hook or crook even if the same ran out of justice and law. He lacked the morals but was not a sole convict as the system lacked strict monitoring authorities. In fact was accompanied with many industrialists, politicians & even with the RBI governor. That's why he screwed up the loopholes more systematically and exploited the financial flaws. Mr. Mehta issued forged bank receipts to the small banks as he was a well established broker. also entered various ready forward deals, introduced replacement cost theory in the absence of a solid watch dog, Indulged into market manipulation, bid rigging, insider trading, stamp paper & other securities fraud's etc. The plethora of unfair practices resulted into the 5000 crore (worth today's 20,000 cr approx.) securities scam, which crashed the stock markets heavily in 1992, when the same was identified by a journalist.



# NEW YEAR'S RESOLUTION





# ACTIVITIES CONDUCTED IN DECEMBER


To keep students updated with the recent updates in tax audit CICASA Indore has organised a seminar on Tax audit with very renowned speaker **CA Pankaj Shah**






